### APIARY INSPECTION SUPERVISOR'S REPORT

Greetings. I have a number of items I wish to share with you.

On the good news front, it's no longer necessary for Illinois to file a Section 18 request with USEPA to gain approval for beekeepers to purchase Checkmite Bee Hive Pest Control Strips for varroa mite and small hive beetle control. USEPA has recently granted Section 3 status to Bayer, manufacturer of the product, concerning national sales of Checkmite. This basically means that the USEPA has found the safety of the product to be sufficient for general sales. If you call a supplier such as Dadant and they say they can't sell the product because Illinois does not have a Section 18, they are incorrect. The product can now be sold without Section 18 authorization.

The IDOA hopes to be able to file a Section 18 request with USEPA soon for the use of "Hivastan" in Illinois. If you recall, there were bee mortality problems with the product last year and it was taken off the market. In speaking with Wellmark (manufacturer of the product) early in 2008, they indicated the toxicity problem is being corrected and they hope to be in a position for the product to be sold this coming spring. We are currently waiting for word from Wellmark as to when we should file the Section 18 application for the product.

Colony Collapse Disorder is certainly on everyone's mind, particularly with the significant problems across the nation last year. Illinois continues to have no confirmed cases of the disorder and as usual, are closely monitoring this situation. Research is underway at the national level to find the possible cause(s) of this ailment. If you believe your colonies may have CCD-like symptoms, please contact me at 217/782-6297 or your Department Apiary Inspector so arrangements can be made for an inspection. We will provide CCD updates as they become available. Updates are also provided on ISBA's website.

Don't let the CCD issue overshadow the need to monitor for other pests/diseases. For example, the small hive beetle (SHB) spread to many new counties in 2006-2007. The total number of Illinois counties affected by the SHB is now up to 17. It's suspected that this intruder is tagging along in package bees, causing part of the problem. Please contact me or one of your Department Apiary Inspectors if you believe your colonies may contain the SHB.

Before we know it, the spring inspection season will be upon us. If you have recently looked at the map on the IDOA's website, you have noted that we again have some vacancies in our Apiary Inspector Team. In addition, Udell Meyer may be unable to perform apiary inspections this year. We need your help in recruiting potential apiary inspectors for the vacant positions, other than the far southern district. We already have a number of good candidates for that area. Please pass this information along to folks who may be interested in being part of our inspector team and encourage them to contact me for more information.

Within the next few months, many beekeepers will move their bees to a different location for various reasons. For those times when colonies will be moved across county or state lines, please be sure to contact me or your Apiary Inspector. The appropriate Apiary Inspector will do an inspection and submit the needed paperwork to our office for the issuance of a moving permit. Please give us a 10-day advance notice before you intend to move the colonies. We will quickly do an inspection and provide the moving permit to you, unless major problems are found. Thanks for your cooperation! β

## Update on The C. C. Miller Memorial Apicultural Library At UW Madison

Jill Rosenshield is the curator of the C. C. Miller Collection, a large and expanding collection of historically important books on beekeeping. The original books in the collections came from the library of Illinois' famous 19th century beekeeper, Dr. Charles C. Miller. Jill wrote recently to let the Illinois beekeeping community know of the progress being made in increasing the accessibility to these seminal works.

"We have nearly completed cataloging the books in the Charles C. Miller Memorial Apicultural Library. Users can go to [www.library.wisc.edu](http://www.library.wisc.edu) and type in the author: Charles C. Miller Memorial Apicultural Library to see the 2361+ titles. Eventually the collection will be digitized by Google, although a rather large number of titles will not be able to be digitized because they are too fragile or because they are bound together (i.e. several distinct titles in one volume). I will send you further updates on the progress of this project."

Illinois owes the staff of the Miller Library a great thanks for their work on behalf of our apicultural forefather.β

## Announcement of the 2008 Value Added Producer Grant Program

USDA published the Notice of Solicitation of Applications (NOSA) in the 1/29/08 Federal Register inviting VAPG applications. Over \$18 million is available for this nationally competitive program. The maximum individual grant amounts are the same as last fiscal year: \$100,000 for a planning grant or \$300,000 for a working capital grant.

The deadline for submitting VAPG applications is March 31, 2008. To assist you in meeting this timeframe, fillable application templates are available on the VAPG website. To access the application templates, please go to the VAPG webpage at: <http://www.rurdev.usda.gov/rbs/coops/vadg.htm>. Please note that this website has not yet been updated with the 2008 application templates or NOSA links. We expect all of this information to be updated shortly. Once updated, click on the Applicants link on the right and then on the Application Requirements link toward the bottom of the screen. This web site also includes an eligibility self assessment tool, which is a good place to start. Links to the program regulations listed in the NOSA are contained on the website, as well.

Please note that the information in the NOSA supersedes and supplements the program regulations. So, you should follow the requirements in the NOSA when developing your application.

We are available to provide a preliminary review of your draft VAPG application if we receive them in our office by February 15th. In the past, all applications were submitted to the National Office in Washington D.C. This year, your application should be submitted to the State Office. IL's State Office address is listed below beneath my name and title. It can also be found in the Federal Register VAPG publication. Applicants may also submit an electronic version through the Grants.gov website. If you have any questions, feel free to contact me via phone or email.
